In the Zero/Near-Zero Truck Cooperative subject area, which has the goal of creating a streamlined process to assist small businesses and encourage fleet turnover, options to encourage adoption of near-zero emission drayage trucks will be developed. The Working Group will discuss options and may recommend one or more approaches for consideration by the MSRC-TAC and MSRC.
