Summary and Conclusions

Scope, Purpose and Background

City of Beaumont used the funding made available through MSRC and other agencies, to install three (3) Electric Vehicle Fast Charging Stations at Beaumont Civic Center parking lot. At the time of project implementation, there were no other fast charging electric vehicle charging stations in the City of Beaumont.

The City of Beaumont first began this project in September 2018 with the application for funding and intended to install only two electric charging stations. However, additional funding was made available for a third fast-charger. After going out for RFP in April 2019, and selecting a contractor, the project was awarded a contract in September 2019. A series of delays hindered progress on the project and delayed completion including weather, impacted Southern California

Edison (SCE) schedule, and Covid-19. The stations were energized and have been put into service on September 18, 2020.

The purpose of the installation of the electric vehicle charging station is to contribute to the State of California's goal of 250,000 electric vehicle charging stations by 2025.

Technical Description and Analysis

Prior to issuing a Request for Proposal, City of Beaumont contacted SCE to visit the intended electric vehicle charging site and determine electrical requirements and upgrades if necessary. It was determined by SCE planners that a new transformer would need to be installed for the project. A walk around determined the location that the charging station would need to be installed to meet electrical logistics as well as convenient parking location for the public use.

Three contractors responded to the Request for Proposal with itemized cost for the units, installation and power upgrades. The lowest bidder was selected to complete the job.

Future Actions and Study

The stations were installed with a 5-year warranty and 5-year subscription to ChargePoint to allow for the service and collection of payment on the stations. It will need to be budgeted to renew the warranty and subscription agreement in five years.


